The 2018 plan includes a slight increase in cost of 4.42% annually and provides the same basic coverage as the 2017 plan with the following exceptions: The maximum out of pocket per employee increase from \$4,500 annually to \$5,000. RHA will continue to contribute up to \$3,000 per employee for eligible expenses using the HRA account to offset the deductible. Kaiser Permanente will continue to provide medical coverage. VSP will continue to provide vision coverage. MetLife will continue to provide dental coverage. Lincoln Life insurance will continue to provide Life Insurance and Disability coverage. PacificSource will continue to maintain the HRA/Flex Spend accounts for each employee. RHA will add the option for employees to add LifeLock to the benefits for \$8.49/month. (Exhibit)
